### Woodland Management

We are at the very early stages of preparing a Woodland Management Plan for the island following a recent conversation with Scottish Forestry. We intend to appoint a consultant to develop this Plan and it is expected this work will take at least 18 months. There is grant funding available to support this work.

Once a consultant is appointed, we are proposing to hold a public community consultation meeting with Scottish Forestry in attendance so that everyone can be made aware of all the rules, regulations, and options, and actively feedback on how Gigha's woodland should be managed. Details on arrangements for the meeting will be made available when appropriate. In the meantime, please note that only clearance of dangerous trees is permitted (with certification for chainsaw use) and an appropriate felling or thinning license is required to clear any woodland within your lease. Achamore Gardens is in the process of applying for a felling license to remove older trees from the shelter belt.

### Holiday Cottages Lease

The Gigha Holiday Cottages Business was leased to LRM Holiday Lets on 1st October 2020. Liz and Richard McCrindle bring lots of experience and enthusiasm to the role and are looking to move to Gigha as soon as possible. We wish them all the very best with the business. ### Gateway to Gigha

IGHT is delighted to have appointed Casey-Jo Zammit as our new Island Countryside Ranger. Casey-Jo is currently based in Cornwall and will be moving to Gigha to start her new role on 2nd November.

A steering group for the island wide pathway, interpretation and heritage conservation work has formed with our Project Manager, Craig Whyte, leading the project. Initial steps are being taken to identify, explore and design the routes across the island. Once these details are confirmed we intend to present these in the newsletter.

### Campsite Update

The Campsite project has been delayed due to COVID-19 implications and procurement matters. Updated timescales will be made available when possible.

### Community Hub Update

It was agreed earlier this year that a new build community hub is not to proceed due to the high expense involved. Scottish Salmon Company kindly donated a portacabin to IGHM which is currently situated behind the Craft Units. It is proposed that the portacabin will act as a community hub. Funding applications have been submitted for furnishing the hub with expectations the hub could be open by Summer 2021.

### Gigha Community Fund

There were no funds awarded during the latest round of the Gigha Community Fund. The next submission deadline for the fund will be the end of January 2021. ### Storage Units

We have noted there is some demand for storage spaces on the island. We are therefore requesting that anyone who has an interest in letting a storage space to contact the Trust office and register their interest. Should there be a high enough level of demand, we will explore options for further storage provisions.

## October in Achamore Gardens

Work has really ramped up in the garden this month, with significant progress now being made in the recovery of Colonel Horlick's First Garden – the area east of the Summerhouse. This area is choked with brambles, overgrown with Rhododendron ponticum and filled with many, many weed tree saplings, so it's going to take us a while to get it back to anything close to its former glory, but Maggie and Ellie, ably assisted by Thomas, Malcolm and some of our volunteers have been doing a brilliant job on the initial clearing of this area. They have removed trailer loads of brambles and Maggie has proved to be a dab hand with a mattock, carefully prying the roots of the brambles out of the ground to help destroy them for good. Ellie has uncovered half a dozen rhododendrons that were so overgrown with brambles that we didn't even know they were there, and everyone has put their back into lopping, sawing and cutting out the Rhododendron ponticum and weed trees. It's hard, muddy work, but the whole team have kept their spirits up throughout, and there's been plenty of laughs along the way. We've had a bonfire burning nearly continuously for the last week to get rid of the Rh ponticum, and it's been a very welcome way to warm up on these wet autumn days. If you are passing by when they are working please give them a cheer to encourage them on in their labours!

## October in Achamore Gardens continued



Rh ponticum is a major weed in the garden as it is very vigorous and resilient so it quickly swamps out other plants, but much worse than this, it is a major vector for a fungal disease called Phytophthora ramorum. This is an imported pathogen which kills susceptible plants (which includes our other Rhododendrons, and many of our tree species) and is causing huge problems in commercial forestry plantations and botanic gardens all over the West of Scotland and beyond; it has already affected Achamore twice in recent years so it is vital that we remove the Rh ponticum to minimise the chance of re-infection. We burn the removed plants as close as we can to where we take them out so that we're not transferring them to other parts of the garden and unwittingly spreading any fungal spores they may be carrying.



I've had a few questions recently about the pink and blue ribbons that are appearing around the garden, so thought I'd take a minute to explain them. These are used to mark plants so that our staff and volunteers can tell at a glance what is to be done with them. Pink ribbons mark plants that are to be removed, and the blue ribbons are for plants that need some gardening intervention (usually pruning, or re-planting) or to highlight a plant to be kept in an area that we are clearing. Please don't remove them if you are visiting the gardens – they are meant to be there.

## Achamore Gardens

We are in the process of appointing a consultant to deliver an Achamore Gardens 10 Year Development Plan which will focus on the overall management and funding strategy for the Gardens. This Plan will form the basis of the on-going restoration of the Gardens. We have also appointed Garden Designers, Rankin Fraser, to start work in the new year (subject to securing funding) to deliver the overall Design Strategy for the Gardens. This strategy will take into consideration the priorities, areas for restoration, areas for new development, facilities required and on-going maintenance of the Gardens. We have also budgeted some funds from the Gateway to Gigha Access project for Achamore Gardens including the upgrading of a route that goes through the woodland and Gardens with some signage and interpretation.

## Housing Update

Following the housing needs feasibility study that was undertaken by Community Housing Scotland in July 2019, IGH is progressing plans for more housing on Gigha. We are now proposing to deliver 5 homes made up of the following:

- 2x 2 Bed Wheelchair Bungalows
- 1 x 2 bed Bungalow
- 2x 1 Bed Cottage flats

An application to the Scottish Governments Rural Housing Fund will be submitted by 31.12.20. Collective Architecture are working up the detailed designs, however the draft design is below.
